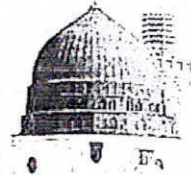
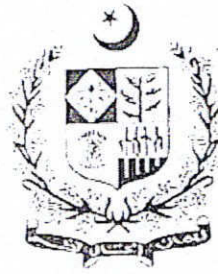
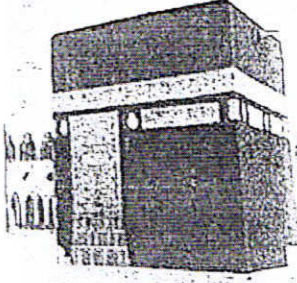

RE-EVALUATION OF ELIGIBLE ENROLLED COMPANIES AS HAJJ GROUP ORGANIZERS (HGOs)

Fresh profiles are invited from 1157 eligible enrolled companies (non-quota holder) for re-evaluation as HGOs, which stood eligible during scrutiny/evaluation in 2018 by third party as per list placed on the website of this Ministry.

1. These eligible companies should fulfill the following formalities:-

- The company should be a private limited registered with Securities & Exchange Commission of Pakistan (SECP) under Companies Ordinance 1984.
 - Should have paid up and authorized capital not less than 5 million and 7.5 million respectively.
 - Should have appropriate office located at proper place, at least 3 employees with adequate furniture and IT facilities. For registered Office proof copy of Form-21 duly certified by SECP is required.
 - The company is not bank defaulter, loan defaulter, insurance defaulter, tax defaulter and is on active tax payer list as on the closing date of receipt of profiles.
 - The management of the company has not been convicted in criminal cases by any court of law.
 - The company is not presently debarred for carrying out its operation in Pakistan and Kingdom of Saud. Arabia or in any other foreign Country in connection with Tourism Department including Umrah/Ziarat as the case may be.
 - Copies of annual Tax returns of the company for the last 3 tax years i.e. 2017, 2018 and 2019, would be required.
 - Company is compliant of annual return to SECP for the last 3 consecutive years i.e. 2017, 2018 and 2019. In support thereof, copies of Form-A for the said 3 years be provided.
2. The re-evaluation/scrutiny shall not entitle any company to claim allocation of business i.e. Hajj quota as a right as it is subject to availability of quota, third party evaluation and fulfillment of the requirements of Saudi Taleemat. Besides, the Ministry will not be responsible for securing Munazam Card of the HGOs enrolled on the basis of aforementioned criteria.
3. Profiles complete in all respects in duplicate (original & copy), must reach to the Section Officer (HGOs) Ministry of Religious Affairs and Interfaith Harmony, Room No. 7-C, 1st Floor, Kohsar Block, Pak. Secretariat, Islamabad within 20 days after publication of this advertisement in the newspaper. Profiles received after due date shall not be entertained.
