OFFICE MEMORANDUM

Subject:- **LABOUR/LOW PAID EMPLOYEES SPONSORED BY PUBLIC SECTOR ORGANIZATION/CORPORATE ENTITIES FOR HAJJ-2016.**

The undersigned is directed to state that as per clause-7(X(b)) of Hajj Policy-2016, approve by the Prime Minister of Pakistan, labour/low paid employees of Public Sector Organizations/Corporate entities will be accommodated against reserved seats subject to payment of Hajj dues under the concept of "Corporate Social Responsibility (CSR)".

2. It is, therefore, requested that the corporate sector entities and public organizations (through their respective Ministry/Department) working under your administrative control may please be directed to furnish the list of employees on the prescribed proforma. Moreover, due to limited availability of seats, the Ministry will review and short list the applicant(s) on case to case basis and consider only those applications of corporate entities and public sector organizations received on prescribed Performa. The procedure/TORs and proforma is available on MORA & IH's website i.e. www.hajjinfo.org.

3. The **nominations must reach this Ministry by 02nd June, 2016**, enabling this Ministry to decide the cases timely. **Applications received after due date will not be entertained by the Ministry.**

**PROCEDURE FOR SUBMISSION OF HAJJ APPLICATION FORM AGAINST
LABOUR QUOTA/ LOW PAID EMPLOYEES FOR HAJJ 2016.**

- i. The applications of the corporate entities for labour/low paid employees quota will be received through Workers Welfare Fund in the Ministry for consideration. The applications from corporate entities shall reach to the following address:

- ii. The Ministry will get verification of the workers identification from EOBI, if required.
iii. The application of public sector organization will be received through their department/organization directly in the Ministry on the following address:

G-6 Markaz, Near GPO,
Islamabad.

- iv. The committee of the Ministry constituted for finalization of reserved quota will scrutinize and finalize all the applications in respect of Labor/Low paid employees, etc.
v. On approval of the committee the Hajj Policy section of the Ministry will issue a letter to the applicant and focal person with a copy to concerned Bank.
vi. The applicants shall receive the Hajj application Form in person from the following branches of the banks on production of original letter of the Ministry and original CNIC/Passport. However, in case of female applicant or in unavoidable circumstances the authority letter may be submitted along with original CNIC-Passport of the applicant. The bank will retain the copy of CNIC of each applicant/person receiving Hajj application Form to avoid any malign activity.

- viii. Applicant will fill the form and submit it in the same branch along with the original letter of the Ministry, having embossing seal of Ministry, Passport and Hajj dues.
- ix. The Banks will forward the Hajj application form along with Passport to focal branch which will subsequently be submitted to DD (HC) on the day/next day of receipt of Hajj application form.
- x. The Hajj application form authorized by the committee will not be transferable.
- xi. The applicant should deposit Hajj dues alongwith the form within 07 days in bank otherwise it would be treated as cancelled / lapsed.

- No substitution in nominations is allowed except death and disease cases subject to submission of documentary proof.
- All nominations should be submitted through Head Office / Department.
- No separate nominations would be entertained.
- Nobody is allowed to perform Hajj on government expenses
- In case of Public Sector organizations/departments, the nomination agency has to furnish a certificate to the effect that the Hajj expense/dues of the nominee are not being funded by the government budget (only for public sector organizations).
- Copy of EOBI card of each worker/labour shall be attached.
- The applications of the corporate entities for labour/low paid employees quota will be received through Workers Welfare Fund in the Ministry for consideration. The applications from corporate entities shall reach to **Syed Nouman Shah, Director, Workers Welfare Fund (WWF), Mauve Area, G-10/4, Islamabad.**
