I am directed to refer to the subject noted above and to say that the competent authority has been pleased to offer you Hajj quota of 50 Hujjaj for Hajj 2017 on the following terms and conditions: -


- i. This offer is only for one year i.e. for Hajj 2017.
- ii. The company will abide by all terms and conditions of Hajj Policy 2017 and will sign Service Provider Agreement (SPA)- 2017.
- iii. The company will submit performance guarantee @ 10% of packages (package x quota) in the form of Bank/Cash Guarantee, valid for one year, at the time of submission of documents in the Ministry. The performance guarantee will be released on satisfactory performance after Hajj 2017.
- iv. The company will provide following documents:-
 1. Filled in company profile on attached format
 2. Certified copy of incorporation certificate.
 3. Form-3 issued by SECP indicating paid up and authorized capital Rs.7.5 and 10 million respectively. Those companies which did not up-grade the paid up and authorized capital, as yet are required to upgrade it within 30 days of receipt of this letter.
 4. Certified copy of latest Form-29 issued by SECP
 5. Certified copy of latest Form-21 issued by SECP
 6. Certificate from FBR to the effect that the company is not tax defaulter
 7. Certificate from SBP that the company is not loan defaulter



8. Valid audit report for the period 2015-16
9. Affidavit from Chief Executive on stamp paper of Rs. 500 duly attested by Notary Public to the effect:--
 - a) That the company is not black listed in KSA or Pakistan
 - b) The Chief Executive, Director(s) and share-holder are not convicted / involved in any criminal/ civil/ administrative offence, particularly an offence relating to dishonesty, fraud / forgery in financial investment / business crime/ misconduct or other criminal acts or been involved in any acts of misfeasance etc
 - c) All terms and conditions issued by the Ministry of Religious Affairs for allocation of Hajj quota – 2017 are acceptable to the company.
10. The company will be responsible to secure Munazzam Card by M/o Hajj, KSA for Hajj arrangements. In case of any delay on account of Hajj arrangements, this Ministry shall not be responsible.

2. If the above terms and conditions for Hajj business 2017 are acceptable to you, the above documents shall be submitted by **4th July 2017** in HGOs Section, Ministry of Religious Affairs. In case of failure, this offer will be treated as cancelled.
