Saudi Arabia to issue Umrah permit for all foreign bilgrims aged 18 and above

IAKKAH - The Ministry of Hajj and Umrah has canceled the maximum age limit of 50 years as a rerequisite for pilgrims coming to perform Umrah from outside Saudi Arabia, Okaz/Saudi Gazette as learnt from well informed sources.

arlier, the ministry has set the age limit of the minimum 18 years and maximum 50 years to book an pointment and issue permit to perform Umrah, as well as prayer at the Grand Mosque and Alawdah Sharif at the Prophet's Mosque and visit the Prophet's grave following the easing of strictions that were imposed since the outbreak of coronavirus.

Inder the new regulations, the elderly foreign pilgrims can come to perform Umrah and that is in ne with the precautionary measures and preventive protocols to stem the spread of coronavirus.

oreign pilgrims under the age of 18 will not be allowed to perform Umrah. As for domestic ilgrims, all those aged 12 years and above will be granted permit for Umrah and prayer at the Two loly Mosques provided that they received two doses of vaccination against coronavirus.

he Ministry of Hajj and Umrah recently launched the service of issuing permits for Umrah as well s for access to the Grand Mosque in Makkah and the Prophet's Mosque in Madinah for those oming from outside the Kingdom through the Eatmarna and Tawakkalna applications that are ploaded on the smartphones of the pilgrims:

/hile social distancing measures were lifted, pilgrims were still required to wear face masks and take reservations to perform Umrah and prayers in order to verify their immunity status at the atrances of the Two Holy Mosques.

ustodian of the Two Holy Mosques King Salman recently issued an order to allow using the full apacity of the Grand Mosque and the Prophet's Mosque for pilgrims and worshipers. Umrah ilgrims and worshipers are required to wear masks at all times when they are within the Grand Iosque and its courtyards.

he Saudi government on Thursday announced the lifting of travel ban on six countries, including idonesia, Pakistan, India and Egypt effective from Dec. 1. These four countries used to send the irgest contingents of Umrah pilgrims before the outbreak of the COVID-19 pandemic.

he King's order to use the full capacity of the Two Holy Mosques and the latest lifting of the travel an will be a big boost to the inflow of foreign Umrah pilgrims over the coming period after a hiatus f nearly two years.

- 1. Allowing direct entry to the Kingdom from the following countries: (Republic of Indonesia, Islamic Republic of Pakistan, Federal Republic of Brazil, Socialist Republic of Vietnam, Arab Republic of Egypt, Republic of India), without the need to stay (14) days outside these countries before entering the Kingdom. Institutional quarantine procedures must be applied for a period of (5) days, regardless of passengers' immunization status outside the Kingdom, with the continued application of exceptions issued regarding some groups in this regard.
- 2. The instructions mentioned above shall be effective as of (01:00) am hrs. on Wednesday, 01/12/2021.
- 3. All airlines must continue to keep the travelers aware about the importance of complying with the precautionary and preventive measures approved in the Kingdom of Saudi Arabia.
- 4. Failure to comply with the circulars issued by GACA is an explicit violation of Government order. Legal procedures shall be initiated against violators who will be held responsible.



Requirements for Umrah Pilgrims Coming to the Kingdom from Non-restricted Countries



Umrah pilgrims coming to the Kingdom on an Umrah visa, and who are vaccinated with one of the vaccines approved by the Kingdom

are allowed to start performing Umrah immediately upon arrival. There is no requirement to quarantine.



Umrah pilgrims coming to the Kingdom on an Umrah visa, and who are vaccinated with one of the vaccines approved by WHO

must quarantine for a period of three (3) days. Forty-eight (48) hours after the completion of quarantine, these pilgrims must submit a negative (PCR) laboratory test certificate before they can perform Umrah.



* Note:

All pilgrims coming from abroad must be immune (completed the doses of COVID-19 vaccine).
