HIRING OF SERVICES FOR HAJJ MEDICAL MISSION FOR HAJJ – 2027

Ministry of Religious Affairs & Interfaith Harmony (M/o RA & IH) invites applications from Regular Government Servants working as Medical Officers, Public Health Specialists, Pharmacists & Paramedics working in Federal, Provincial, G.B and AJ&K Government Health Departments / Hospitals (up to BPS –18) for provision of Medical related services to the pilgrims in the Kingdom of Saudi Arabia (KSA) during Hajj–2027 through Open Testing Service – Pakistan (OTS). Selection in various categories shall be made on the Federal / Provincial / Regional FPSC quota. Regular Federal/ Provincial Government Doctors, Public Health Specialists, Pharmacists & Paramedics possessing the requisite qualification, age, experience and domicile of the respective Provinces and Regions are eligible to apply;

He / she should be a Federal / Provincial Regular Government Servants working as Doctors, Public Health Specialists, Pharmacists and Paramedics including GB & AJK up to BPS –18. ii. Fresh candidates shall not be less than 25 years and more than 50 years of age as on the closing date of applications. iii. Repeater candidates shall not be less than 25 years and more than 55 years of age as on the closing date of applications.

Should have at least 03 years' service/experience in the relevant field, at his / her credit. (No contract or Adhoc service will be considered). The experience will be calculated from date of appointment to closing date of applications. v. Should be medically / physically fit in all respects, due to special nature of assignments, disabled / handicapped Government employees are not eligible. Employees having heart, hypertension, diabetic, chronic diseases or any other kind of medical or mental disability / disease are not eligible. Candidates are required to provide medical fitness certificate from concerned DHQ Hospital. The medical team appointed by this Ministry will be authorized to verify physical fitness certificate or re-assess it if necessary. vi. Repeaters shall be selected up to maximum 30% of the total strength of each category of HMM contingent. Repeaters who have performed three (03) or less Hajj duties in KSA as Hajj Medical Mission are eligible to apply. Those who have performed more than three (03) Hajj Duties are not eligible.

General Terms and Conditions

- i. The applicants shall be assessed through test conducted by OTS.
- ii. For Specialist FRCS/ FCPS / FRCP is required.
- iii. The information provided by the candidates in the OTS online application form shall be considered as final no change or excuse will be accepted at any later stage.
- iv. The candidates' substantive pay scale shall be considered as final to determine the eligibility, category and other benefits. Therefore, candidates should apply in the respective category as per their substantive pay scale.

- v. Departmental No Objection Certificate (NOC) should be obtained well in time and shall be provided by the candidate as communicated on official website of the Ministry www.mora.gov.pk and OTS www.ots.org.pk in due course of time. Failure of doing so will disqualify the candidate.
- vi. Selected candidates shall be required to submit copies of service and academic documents duly attested by PMDC, HEC and M/o Foreign Affairs by **15.09.2026** for onward submission to KSA Authorities. In case of delay / failure the candidature shall be cancelled.
- vii. Original documents of the shortlisted candidates will be checked at any stage of selection process and in case of any false or wrong information; the selection of the candidate will be cancelled and may entail disciplinary proceedings.
- viii. Family members of selected Hajj Medical Mission personnel shall not be allowed to proceed to KSA for performance of Hajj or Umrah during their stay in KSA.
- ix. Past adverse report against the candidate during any hajj duty in KSA or during training in Pakistan will bar him / her from selection.
- x. Original documents of the shortlisted candidates will be checked at any stage of selection process and in case of any false or wrong information; the selection of the candidate will be cancelled and may entail disciplinary proceedings.
- xi. M/o RA & IH reserves the right to increase or decrease number of HMM in any category keeping in view the actual requirement in that category as per Hajj quota / Saudi Taleemat.
- xii. This Ministry reserves the right to cancel/withhold the selection process at any stage without assigning any reason thereof.
- xiii. Based on nature of duties in KSA, selection of Male & Female ratio will be 70:30%.
- xiv. All candidates are only eligible to apply for one category of welfare staff. Candidates are not allowed to apply in two categories of welfare staff (Khuddam and Hajj Medical Mission simultaneously). Those candidates who apply in more than one category of welfare staff shall stand disqualified at the initial stage due to restrictions of Saudi Masar System that allows entry of passport only once.
- xv. Shortlisted candidate will have to produce **MRI passport scanned copy** valid up to **16.11.2027** by **15.09.2026**; otherwise their selection will be cancelled.
- xvi. No TA / DA will be admissible to the candidates during selection process.

How to Apply

- i. Please visit the OTS website (www.ots.org.pk) for online registration and submission of the application form. **Last date to apply is 27.08.2026.**
- ii. To submit the **application fee**, login to your banking app, select “1-Bill Payment”, enter your PSID, verify the details, and complete the payment.
- iii. Candidates are required to upload scanned attested copies of all educational documents, CNIC front back, copy of domicile, all experience letters, Copy of employment record as Permanent Government servant, Latest Salary Slip and Nomination proforma and Undertaking, Medical Fitness Certificate, Service No Objection certificate (NOC), Surety Bond on stamp paper, Candidate Bio Data Form, Copy of Office Card, Undertaking by the repeater Candidate if already perform the Hajj duties more than three (03) times in KSA as member HMM, sample already uploaded on ots.org.pk, and all relevant documents through the online application portal.
- iv. **Online application form filled improperly, incomplete and submitted by hand will not be entertained.**
- v. Shortlisted candidates will submit **requisite documents in original to M/o RA & IH** as and when asked by M/o RA & IH.
- vi. After applying for the post(s), applicants are advised to regularly check OTS website www.ots.org.pk & applicant portal for important announcement (Procedure for Roll No. Slip/Written Test Schedule/ Result etc.) Related to recruitment against the above posts.
