**SUBJECT: IMPLEMENTATION OF ZAIREEN MANAGEMENT POLICY**



- iv. Finalization of MOUs for "Cooperation in the sphere of Zaireen Hospitality" already shared with Iran, Iraq & Syria; and
- v. Any other task related to the implementation of the Zaireen management Policy.
